

2020 Elections Voter Eligibility Criteria for Individual and Club Director Positions

This document describes the USAC voter eligibility criteria used by the NGC to confirm registered USAC individual members and registered USAC club members who are deemed eligible to vote in the 2020 USAC elections. The eligibility criteria is based on the USAC Constitution and additional USAC-imposed membership requirements, as permitted by the Constitution, as well as USAC-sponsored Membership-approved Board resolutions that apply to the 2020 elections. The NGC has additionally sought clarification and guidance when needed from the USAC Counsel and the USAC Board.

The membership information used to determine eligibility is the individual member and club member data as it existed on 9/19/2021. The club nominee information (which was not part of that data) was separately collected by the USAC through 3/9/2022 except for any NGC allowed changes to the nominee information that were subsequently made.

Note that the highlighted parts of the eligibility criteria are USAC imposed requirements as permitted in the Constitution for these elections.

Individual Member Eligibility Criteria

- Must have registered by 3/15/2021 2359 US PDT if member is not an official and by 3/22/2021
 2359 US PDT if member is an official
 - The player or child-parent deadline in specific instances has been extended by USAC due to membership portal issues
- Must have paid dues by 9/19/2021 2359 US PDT
- Must have a valid personal email address and a valid personal phone number
- Must be at least 18 years old on 3/15/2021 (i.e., valid date of birth of 3/15/2003 or earlier)
- Must have a player role or official role
 - o parent role is not eligible
- Male player member must not also be an eligible male international player
 - o An eligible male international player votes instead for the male player director
 - An eligible male international player is one who has played for the USA Senior Men's Representative Team between 3/16/2011 and 3/15/2021 in ICC sanctioned tournaments.
- Female player member must not also be an eligible female international player
 - o An eligible female international player votes instead for the female player director
 - An eligible female international player is one who has played for an ICC country's Senior Women's Representative Team including USA, between 3/16/2011 and 3/15/2021 in ICC sanctioned tournaments.



Club Member Eligibility Criteria

- Must have registered by 3/15/2021 2359 US PDT or given an extension to register by USAC
- Must have paid dues by 9/19/2021 2359 US PDT
- Must be affiliated with a "primary league" or "other league" (if the league has not registered as a USAC member league)
- Must have at least 12 player members, made up of adults (18 years old or over as of 3/15/2021) and youth (under 18 years old as of 3/15/2021), who have chosen the club as "primary" or "other club" in their individual member record.
- Must have a unique designated club nominee with full name, club position, valid personal email address, and valid personal phone number.
 - o If multiple eligible clubs designate the same nominee, only one of these clubs will be deemed eligible.
