

USA Cricket Independent Director Board Application

October 23, 2022

Applications are requested for the following <u>three positions</u> as Independent Directors of the USA Cricket (USAC) Board of Directors:

- A. One position for a 3-year term;
- B. One position for a 2-year term; and
- C. One position for a 1-year term

Note: The Candidate selected for each of the above vacant positions, would be eligible to compete for a consecutive term of three years, contingent upon meeting all requirements enshrined in the Constitution.

The USAC was established in 2017 to be the national governing body for the sport of cricket in the United States of America, and is recognized as an Associate Member of the International Cricket Council (ICC). It is a 501(c)(3) charitable nonprofit organization incorporated under the laws of the state of Colorado, but is now headquartered in the San Francisco Bay Area, California. Its mission is to govern, regulate, develop and promote the sport of cricket (including hardball, softball, disabled and all other types of cricket) at all levels in the United States, and to enable United States cricketers to successfully compete in national and international competitions.

To be eligible to apply, an individual **must**:

- i. Be a U.S. Citizen or Permanent Resident and at least eighteen (18) years old;
- ii. Possess a high degree of personal and professional integrity, understanding of sporting ideals and values, qualifications of leadership in business, and sound ability and judgment;
- iii. Pass any applicable background screening instituted by the Nominating and Governance Committee (NGC);
- iv. Be fit and proper, including having no material conflicts, as determined by the NGC, to serve as a Board Director; and
- v. Demonstrate a high level of experience, capability, success and leadership in Board oversight responsibilities in one or more of the following areas: business, finance, marketing, fundraising, ethics, audit, legal, management, communications, and sports.

Also, eligible applicants must not:

i. Be a paid employee, consultant, or have any other material professional, personal, business and/or financial relationship (whether directly or indirectly) with the USAC, the ICC, the USOC, or any of their affiliates/partners;

- ii. Have held an elected position in, served as an employee, officer, or director of, or held any governance position (whether as an administrator, appointee, or otherwise) in the USAC, the ICC or any national, local or regional governing or administrative body established for cricketing purposes in the United States within three years of the date of the applicable election;
- iii. Have any immediate family member elected as a Director of the USAC;
- iv. Be directly or indirectly associated in any way with the USAC outside auditor or outside counsel;
- v. Have a record of a felony criminal conviction involving theft, financial impropriety and/or other crimes involving moral turpitude; and
- vi. Have been found guilty of violating any rules or regulations of the USAC or the ICC, any other member of the ICC, another National Governing Body recognized by the USOC, or the U.S. Center for Safe Sport, where such violation has resulted in the imposition of a period of suspension from cricketing activity of one year or more;

Note: If you are selected as a USA Cricket Board member, you will be required to obtain and submit records of a full criminal background check.

<u>Key Expectations</u> of performance as a Board Member are to:

- Uphold the Constitution and the mission of the USAC;
- Work as a part of a cohesive team seeking to accomplish common goals;
- Dedicate time to the USAC including regular attendance and active participation in Board and assigned Committee meetings;
- Respect and support the majority decisions of the Board and assigned Committees;
- Participate actively in Board decision-making while sharing his/her skills, expertise and experiences to this end;
- Represent all those whom the USAC serves and not a particular geographic area or constituent group;
- Upon learning of her/his perceived, potential, or actual conflicts of interest, immediately declare to the Board in writing, any such conflict(s) as they pertain to her/his position on the Board;
- Abide with the decision of the Board as to how her/his declared conflicts must be handled;
- Do her/his best to ensure that the USAC is well-maintained, financially secure, growing, and always operating in the best interest of cricket in the United States; and
- Fulfill Board responsibilities while complying with the duties of care, loyalty and obedience.
